### SCHEDULE OF SHARE PROVISIONS

THE CLASSES, AND ANY MAXIMUM NUMBER OF SHARES THAT THE CORPORATION IS AUTHORIZED TO ISSUE:

- 1. Class A Common shares, an unlimited number, the holders of which are entitled:
- (a) to vote at all meetings of shareholders; and
- (b) to receive the remaining property of the Corporation under dissolution.
- 2. Class B Preferred shares, an unlimited number, which shall carry the right:
- (a) to a dividend as fixed by the board of directors; and
- (b) upon the liquidation or winding-up of the Corporation, to repayment of the amount paid for such shares (plus any declared and unpaid dividends) in priority to Class A Common shares, but they shall not confer a right to any further participation in profits or assets.
- 3. The said Class B Preferred shares or any part thereof shall be redeemable at the option of the Corporation without the consent of the holders thereof at a price equal to the amount paid up thereon plus any declared and unpaid dividends.
- 4. The holders of the Class B Preferred shares shall not be entitled to vote at all meetings of shareholders except as otherwise specifically provided in the Business Corporations Act.

### SCHEDULE OF RESTRICTION ON SHARE TRANSFERS

The right to transfer shares of the Corporation is restricted in that no shareholder shall be entitled to transfer any share or shares in the capital of the Corporation to any person who is not a shareholder of the Corporation unless the transfer has been approved by the directors of the Corporation.

### SCHEDULE OF OTHER RULES OR PROVISIONS

- 1. The number of shareholders of the Corporation, exclusive of persons who are in its employment and are shareholders of the Corporation and exclusive of persons who, having been formerly in the employment of the Corporation, were, while in that employment, shareholders of the Corporation and have continued to be shareholders of the Corporation after termination of that employment, is limited to not more than fifty persons, two or more persons who are the joint registered owners of one or more shares being counted as one shareholder.
- 2. Any invitation to the public to subscribe for securities of the Corporation is prohibited.
